**Subj: Revised Procedure for Deposit towards Chief Minister's Health Insurance Scheme (CMHIS).**

In partial modification to this Department's OM of even number dated 7<sup>th</sup> November 2022, the 50% of the monthly Medical Allowance amount which are presently being transferred to the "Head of Account 8011-00-105-01 - Chief Minister's Health Insurance Scheme" shall be transferred to the Bank Account indicated below w.e.f 1<sup>st</sup> July 2023.

- All the concerned Banks/DDOs/Treasury Officers/ Heads of SPSUs/ Boards/ Statutory Bodies/ State Corporations, etc should therefore, ensure that the converted amount is deposited/ transferred in to the above mentioned Bank Account and continue to ensure that the details of employees and pensioners, amounts and deposits/ transfers are maintained and that such details are provided to the Principal Director of Treasuries and Accounts every month.
- The Bank Account indicated at para 1 shall be a Joint Savings Account to be operated jointly by Chief Secretary and Finance Commissioner. Finance Department shall have custody of the Account.
- The Health & Family Welfare department on receipt of proposal from Nagaland Health Protection Society through the Principal Director, Health & Family Welfare will submit the matter to Finance Department for approval and issue of Cheque.
- The balance available under the Head of Account "8011-00-105-01 - Chief Minister's Health Insurance Scheme" will be immediately transferred to the stated Bank Account.

**Subj: Revised Procedure for Deposit towards Chief Minister's Health Insurance Scheme (CMHIS).**

1. In continuation to this department's OM of even number dated 14-6-23 this is to revise the effective date for transfer of the converted 50% Medical Allowance into the notified Bank Account in the Nagaland State Co-operative Bank from 1<sup>st</sup> July to 1<sup>st</sup> August 2023.
2. It is clarified that the maximum amount to be converted from Medical Allowance towards CMHIS is fixed at Rs. 400/- per month per employee or pensioner or 50% of Medical Allowance, whichever is lower.
